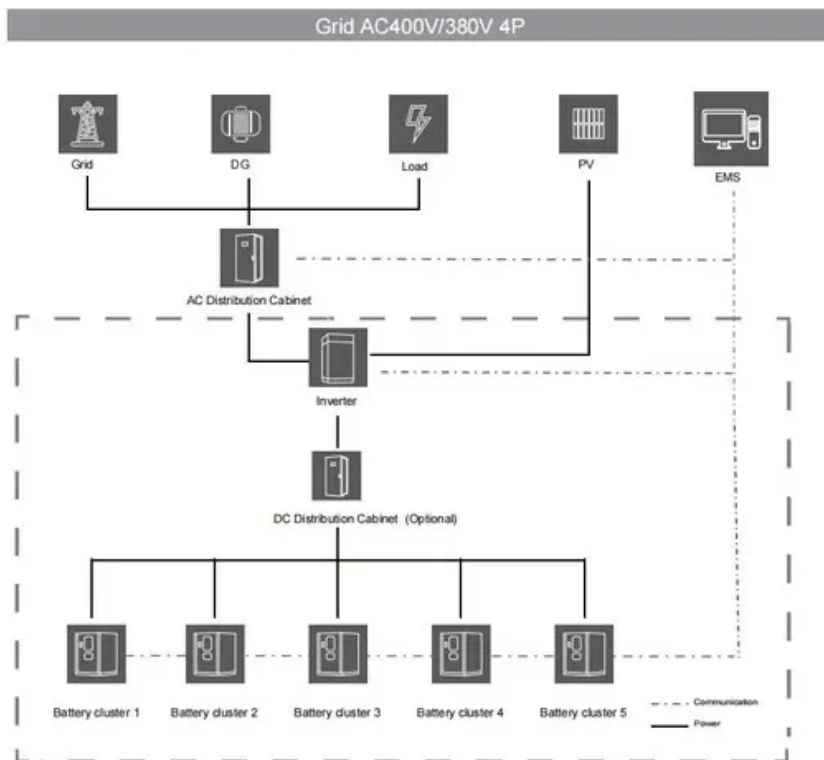


# Container Generator Regulations

These standards are found in title 40 of the Code of Federal Regulations (CFR) in part 262. The generator regulations ensure that hazardous waste is appropriately identified and handled safely to protect human health and the environment, while minimizing interference with daily. The Resource Conservation and Recovery Act (RCRA) regulations establish basic hazardous waste management standards for persons who produce hazardous waste, called hazardous waste generators. 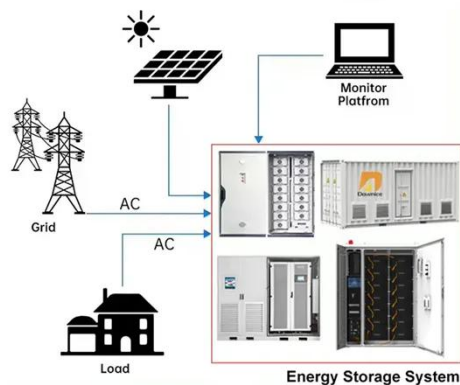
A generator who handles hazardous waste on the site of its generation also must comply with applicable standards and requirements set forth in Chapters 850, 852, 854, 855, 856 and 857.

Master the federal rules for hazardous waste storage. Status determines container mandates, accumulation time limits, and required training.

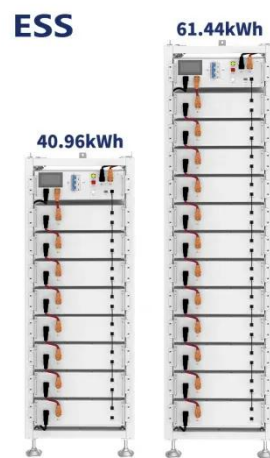
