The rooftop solar tax credit offers an uncapped tax credit to cover 30% of eligible costs of purchasing and installing solar panels for all homeowners who pay federal income tax. If you invest in renewable energy for your home such as solar, wind, geothermal, fuel cells or battery storage technology, you may qualify for an annual residential clean energy tax credit. The Residential Clean Energy Credit equals 30% of the costs of new, qualified clean energy property for you. Whether you're a low-income homeowner or a rural resident, there are plenty of grants and funding options in 2025 to make solar energy accessible, affordable, and efficient. In August of 2022, the United States Federal Tax Credit Under Threat: The 30% federal solar tax credit, worth \$4,000-\$15,000+ for most households, faces potential elimination by December 2025 due to pending Congressional legislation, making 2025 a critical year to act. Income-Qualified Programs Expanding: The EPA's \$7 billion Solar. If you purchased and installed a qualifying rooftop solar system by the end-of-year deadline, you can claim the credit by submitting IRS Form 5695 with your federal tax return.

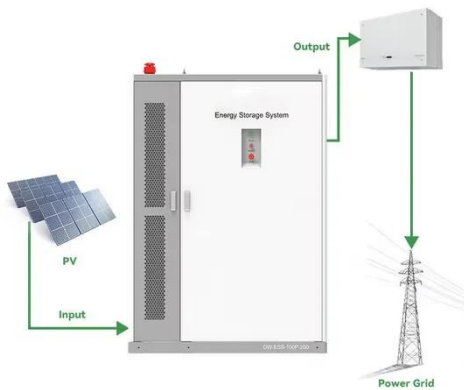

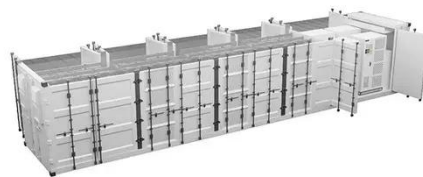

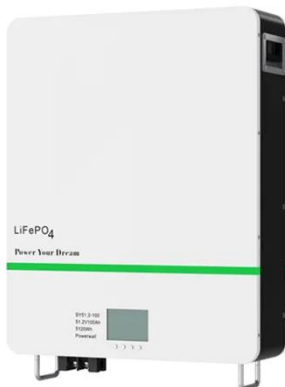
