Overview

import tariffs on photovoltaic (PV) equipment, including inverters, have not yet precipitated a sharp decline in inverter inventories due to substantial “pre-tariff” stockpiles that remain in the distribution pipeline. In early April 2025, the United States enacted sweeping “reciprocal tariffs” on imports, aiming to mirror (at a discounted rate) the trade barriers faced by U. Announced on April 2, President Trump's so-called “Liberation Day” tariffs set a universal 10% baseline tariff on all. The US Commerce Department set final countervailing and anti-dumping duty rates on Monday for crystalline solar cells and modules imported from four southeast Asian countries. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. Importers have already been posting cash. In April 2025, the U. These tariffs, varying between 10% and 50% depending on the country of origin, have introduced new challenges for the solar. Clean Energy Associates released a summary of the seven solar module trade policies and solar panel import tariffs currently in place, including AD/CVD rulings, Section 201/302, and the Uyghur Protection Act.

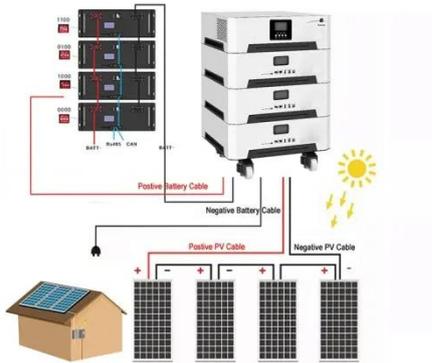


